- 2.4. The Presentation shall follow the specification set out in clause 3 and any other specifications set out in the Form.

# 3. CONTENT, ELIGIBILITY AND PERMISSIONS

- 3.1. Participants warrant that any Presentation submitted is their own original work and does not infringe any third-party intellectual property rights in any way.
- 3.2. Participants promise that the content of their Presentation will not be in any way defamatory or offensive.
- 3.3. Participants agree that Informa may record their participation in the Event and that any photograph(s) and/or audio/video recording(s) taken of Presenters (the **Recording**) can be used by Informa in accordance with these Terms and Conditions.
- 3.4. Participants give Informa the permission to use, distribute, publish and/or promote all or part of the Recording or any derivative work(s) of the Recording and license others to do the same, without compensation or further permission, for current or future promotional, educational, informational, commercial or other business purposes, except that the Presentation shall only be used by Informa in connection with the Forum and shall not otherwise be shared.
- 3.5. Participants verify that they have the authority to grant the rights to use the Recording in the ways described above and, where necessary, they have obtained all relevant permissions and consents from third parties and employers.
